Scholarships are disbursed by the foundation, and the foundation is thus controller in the function of fulfilling its purpose of processing applications for scholarships and administration of disbursement. Consequently, we process the following personal information when you send your application to us: name, address, phone no., e-mail address, student registration number ("årskortnummer"), education, place of study, supervisor's name and AU address, and possibly a transcript. The source of these data is you as an applicant in connection to this application form¹.

The personal data will be shared with Aarhus University, who is the administrator of the foundation and thus the scholarships. The personal data is only kept for as long as they are necessary for the given purpose. Applications are kept up to and including the day on which the applicant has received a scholarship grant or rejection letter. Consecutively, the data will be archived due to legal requirement.

For applicants and grantees, the given personal data is necessary for evaluating applications and administration of scholarships. If you do not wish to give the information in the application form, you will not be taken into consideration for a scholarship. In the processing of your personal data, you have the right to:

- Request access in and rectification of personal data, or
- Request limitation of the processing of your data, or
- Object against processing
- And in specific cases, the right to receive the personal data you have given (data portability)
- Complain about the processing of your personal data to the Danish Data Protection Agency.

¹ Legal framework: GDPR art. 6.1.b. (necessary for the performance of a contract (the scholarship) that you are a party in) and GDPR art. 6.1.f. (legitimate interest). The legitimate interest is to be able to evaluate applications for the purpose of handing out scholarships.
